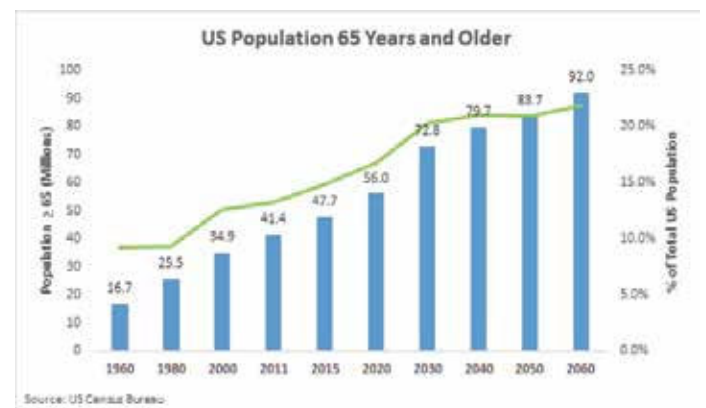

Fifteen states have franchise investment laws that require franchisers to provide pre-sale disclosures, known as "offering circulars," to potential purchasers. Thirteen of these state laws treat the sale of a franchise like the sale of a security. Oregon and Michigan do not require a filing of offering circulars, as noted in the list of state offices below. States listed below are in the process of being registered: Illinois, Michigan, N. Dakota, Wisconsin, Oregon, California, Indiana, Minnesota, Rhode Island, Virginia, Hawaii, Maryland, New York, S. Dakota, Washington.
